The Board of Directors of 800 Super Holdings Limited (the "**Company**") and its subsidiaries, collectively the "**Group**") wishes to announce that its wholly-owned subsidiary, 800 Super Waste Management Pte Ltd ("**800 Super Waste**"), had been awarded a contract by the Public Utilities Board on 27 October 2016 for the treatment and disposal of sludge from water reclamation plants at a contract value of S\$133.65 million (the "**Contract**").

The Contract shall be for a period of fifteen and a half years from 7 November 2016 to 6 May 2032, and is not expected to have any material impact on the earnings per share or the net tangible assets per share of the Group for the financial year ending 30 June 2017.

None of the Directors or controlling shareholders of the Company, as well as their respective associates, has any interest, direct or indirect, in the Contract (other than through their interests in the shares of the Company).
